

A contract is entered into once an Operator receives your deposit and we accept and confirm the booking. Payment of any monies constitutes acceptance and understanding of the Times Journeys Terms & Conditions. These Terms & Conditionsmay be supplemented by additional terms and conditions specific to your Tour ("Supplemental Terms"). In the event of a conflict between these Terms & Conditionsand the supplemental terms, the Supplemental Terms will control.

Times Journeys acts only as the Tour sponsor and is not responsible for the acts or omissions of other parties.

**Travel Purpose:** Tours are intended for tourist travel only, and unless approved by Times Journeys in advance, are not open to individuals looking to conduct business during a Tour. **We reserve the right to decline to do business with anyone.** 

**Pricing and Inclusions:** Quoted Tour prices are per person, double occupancy except where indicated. Prices include programming, planning, handling and operational charges and are based on current rates of exchange, tariffs and taxes in effect at the time of publication. We reserve the right to increase Tour prices at any time prior to final payment, except for increased governmental taxes which can be passed on at any time, to cover increased costs, tariffs, taxes and V.A.T. received after prices are published and to reflect fluctuations in foreign exchange markets.

**Exclusions:** Quoted Tour prices exclude trip insurance; airfares between points on the Tour; international airfare, including airfare and other transportation to and from the Tour (unless otherwise noted); costs associated with obtaining passports or entry visas; airport departure taxes (unless otherwise noted); excess baggage charges; gratuities to the drivers, local guides and Tour Directors; meals other than those specified in the Itinerary; sightseeing not included in the Itinerary; and personal expenses such as laundry, communication charges and optional activities (which are subject to availability).

Reservations and Payments: The Tour deposit amount is listed on the Website or in your brochure. The deposit is required in order to confirm your booking. Upon receipt of the deposit, the Operator will send you confirmation of your booking. Your final payment date will be listed on the confirmation. If a Tour is already full, Times Journeys will accept deposits on a standby basis. If space becomes available, you will have the choice of joining the Tour by paying in full or forfeiting the space in return for a refund of your deposit. Final payment is due ninety (90) days prior to the Tour's departure unless otherwise indicated on the Website or in the brochure. If your reservation is made within ninety (90) days of departure, the entire cost of the trip must be paid at the time of the request in order to secure confirmation.

From time to time, Times Journeys may issue a Future Travel Credit ("FTC"), redeemable as partial payment of a newly booked Tour. The value of the FTC will be communicated at the time of issuance, can be redeemed against a new booking only, and unless otherwise indicated, must be redeemed within twelve (12) months of date of issuance. **Travel Protection:** Times Journeys recommends that you purchase trip cancellation and medical protection. Any questions about what travel protection does or does not cover should be addressed directly to the travel protection company. If you decline travel protection coverage, you will personally assume full responsibility for any financial loss associated with your travel arrangements, and you could lose your travel investment and/or have to pay more money to correct the situation. Your decision not to participate in the Tour due to State Department Travel Advisories, fear of travel, illness, or any other reason will be deemed a cancellation. If a flight or other delay for any reason prevents you from joining the Tour on the Tour departure date and time, you will be considered a no-show, and Times Journeys will not provide a full or partial refund or credit toward a future Tour, but you may join the Tour late if you wish.

Any fees imposed by an airline, including for airline service between points on the Tour ("Internal Air") or travel to or from the Tour, are your responsibility.

Air Transportation During the Tour: Internal Air is not included in the price of the Tour. Estimated Internal Air costs will be identified separately on the Website or in your brochure.
